# Industry update 13 Tomato potato psyllid (TPP) complex

### **New detections**

The Department of Agriculture and Food has confirmed two new detections of tomato potato psyllid (TPP) since the last update on 12 April.

The psyllid has been confirmed on a total of 73 properties/locations, of which 41 are commercial horticulture properties, mostly in the metropolitan control zone.

There has been no detection of the associated bacteria *Candidatus* Liberibacter solanacearum (CLso) to date.

# **Transition to management**

The National Management Group (NMG) is the decision making body for national exotic plant pest eradication programs under the Emergency Plant Pest Response Deed (EPPRD).

A NMG meeting was held on Thursday 20 April.

The group agreed that TPP is no longer technically feasible to eradicate and additional surveillance will take place to provide confidence that the associated bacteria CLso is not present in Australia. The group has agreed to the development of a transition to management plan.

The department is working with industry and national partners to develop the transition to management plan, to prepare industry (in WA and nationally) to manage this pest, with a focus on limiting the spread of the psyllid and minimising the impact on affected industries. This work includes identifying key areas where further research and information is required to improve management outcomes and market access.

The national Consultative Committee on Emergency Plant Pests (CCEPP) will continue to meet while the transition to management plan is developed in consultation with affected industry groups.

The department will continue to keep the horticulture industry informed of further developments.

# **Response Update**

The department is working closely with the horticulture industry to reduce the impacts of TPP on businesses and the WA economy.

#### **Quarantine Area Notice**

A *Quarantine Area Notice* in Western Australia remains in place to help prevent the spread of the psyllid.

It includes zones to direct the movement and treatment of commercially-produced vegetables and seedlings, to help contain and control the pest.

A control zone covers the Perth metropolitan area and surrounds; a suppression zone extends from Augusta-Margaret River in the south to Dandaragan in the north and to Brookton in the east; and a watch zone is in place for the remainder of the State.

Alternative protocols for intrastate host plant (seedling) movement from the quarantine area and an approved manner of preparation for movement from the quarantine area have been developed. The Quarantine Area Notice will remain in place until a cost benefit analysis for area freedom for TPP in WA is completed and discussed with industry.

# Surveillance and testing update

Surveillance for the psyllid and the CLso bacteria is continuing.

Department officers have inspected more than 1200 properties across the State. This includes more than 530 commercial horticulture and retail properties.

There have been more than 500 properties surveyed in the outer watch zone, encompassing Albany, Carnarvon and Geraldton, with no detections of the psyllid or CLso.

More than 7000 surveillance 'sticky' traps have been installed in regional and metropolitan areas. Many traps are being 'hosted' by supportive residents with home vegetable gardens. Traps are collected for analysis by the department and inspected for the psyllid. Psyllids are tested for the CLso bacteria.

The department has completed TPP/CLso surveillance of all commercial seedling nurseries in the Quarantine Area and is sampling all commercial seed potato properties. More than 8800 plant samples have been tested for CLso, and more than 22000 tuber samples have had the 'zebra chip screening' with no detection of CLso.

#### Interstate trade

New South Wales, South Australia, Victoria, Queensland and the Northern Territory have emergency interstate movement controls in place for Tomato potato psyllid and *Candidatus* liberibacter solanacearum (CLso) host fruit, vegetables and plant material, and used machinery and equipment from WA.

South Australia has introduced new restrictions on a broader range of plant material which came into effect on Thursday 20 April. Dried plants, seed (other than potato), mulch, timber, chaff and hay are exempt from these conditions.

NSW and Victoria introduced additional restrictions in late March on a much broader range of conditional non-host plants and produce. Victoria has since amended these restrictions to exempt dried plant products; seed; mulch; timber; chaff and hay from treatment and

certification for entering Victoria. Full details of the entry conditions are updated on the <u>NSW</u>, <u>Victorian</u> and <u>South Australian</u> department websites.

The department's market access team is developing proposed protocols and is in dialogue with other states to facilitate interstate trade for Western Australian host and non-host produce as quickly as possible.

# **Check and report**

Commercial horticulture producers, particularly in regional areas, should check for signs of the psyllid and report via MyPestGuide Reporter app, email or phone.
